"land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income:

"relevant authority" means the council of which you are a member;

"relevant period" means the period of 12 months ending with the day on which you notify a disclosable pecuniary interest;

"relevant person" means you or your spouse or civil partner, a person with whom you are living as husband and wife, or a person with whom you are living as if you are civil partners;

"securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

If you consider that the disclosure of the details of a disclosable pecuniary interest could lead to you, or a person connected with you, being subject to violence or intimidation, you should contact the Monitoring Officer. If he agrees and, if the interest is entered on the register, copies of the register that are made available for inspection and any published version of the register will exclude details of the interest, but may state that you have a disclosable interest, the details of which are withheld under Section 32(2) of the Localism Act 2011.
