# **Moss Lane Park Report**

Most of the Council's focus has been on the Children's Play Area.

The play area has been improved by laying a paved entrance from the Moss Lane end and replacing the crazed paving area with new paving and the installation of wheelchair friendly picnic benches.

We have not been happy with two of the new pieces of equipment, the Trampoline and the inclusive Roundabout. Neither work satisfactorily and we have been in discussion with the supplier about solutions to both items. The Trampoline as we all know fills with water when we have heavy rain. This is not acceptable and the proposed solution from the supplier is not practical. The Roundabout does not run freely and again the proposed solution is not practical.

We have been unable to meet with the supplier due to covid restrictions. We will be making every effort to improve this over the next few months. Once we have a satisfactory solution, we will begin to look at how we can extend the park to provide more equipment for the children.

The gate at the Kepple Lane end needed to be removed to effect a robust repair to the hinge and spring loaded mechanism. Wyre Council undertook the repair, and the gate was returned at the beginning of April.

The equipment has a weekly safety inspection by Wyre Council.

# **Financial Report**

#### 1 April 2020 -31 March 2021 (the last financial year)

The figures are yet to be approved by Council, on 4 May 2021, and are still subject to audit.

Receipts: The Council set a precept of £76,809. The precept allows the Council to carry out its functions and services for the year. Other sources of income for the Council, included:

- a) Rent from the 3 allotment tenants of £41 each making a total of £123.
- b) The rent from the scout hut (£120 covering 2 years rent).
- c) £3,200 was received from Wyre Council as a grant donation towards the town's Christmas lights (organised by the Chamber of Trade).
- d) £500 was received from Wyre Council as a grant donation towards ICT costs incurred by the Covid 19 pandemic. This money was used to purchase a laptop, headset and offset costs with the new up and running Microsoft Teams.
- e) £500 from Lancashire County Council to assist maintenance of the ProW; Riverside Walk which is maintained by the Town's Lengthsman.
- f) £400 from Lancashire County Council, Champion Grant from County Councillor Paul Rigby, the Champion for Parishes. The monies will be utilised towards the cost to purchase of equipment for the Town council's Emergency Plan.
- g) Lancashire County Council grass cutting monies, paid to the Town Council for the maintenance of the grass verges carried out by the Town's Lengthsman.

**Payments:** A budget is set in November/December prior to the financial year to determine what costs the Council are likely to face in the following financial year. The Council decided to support the following projects in the town.

- A )Kepple Lane playing field project -This project is being led by the Kepple Lane Park Trust, whereby Cllrs Atkinson and Pearson are trustees. Since April 2008 the Council has approved £4,000 each year for the project. At 31 March, the funds for the project amounted to £6,569.
- b) Moss Lane playing field project —this project is being led by recently retired Cllr Ryder and Hynes. Similar to the Kepple Lane project, since April 2017, the Council has approved £4,000 each year for the project. At 31 March, the TC funds for the project amounted to £1,816.00.
- c) The Town Council awarded a grant of £500 (in additional to the £2,500 approved budget figure 180(2019/2020) and Mayor's allowance of £508.52 minute 111(2020/2021).
- d) Sadly due to the pandemic, the town's festivals did not take place along with the Legend Fires North West Stages Rally 2021and VE Day 75 celebrations. Underspent monies were allocated to the projects initiated by the Market Town working group.
- e) A new Council website was produced by Councillors Atkinson and Dyer. The Council had earmarked £2,000 for this project. This saving was transferred into the EMR Market Town working group project.

Other expenditure of the Council relates to salaries (the Clerk and Lengthsman) and for the administrative running costs of the Town Council.

Maintenance of the two playing fields – Kepple Lane and Moss Lane, is paid for by the Town Council and carried outby Wyre Council. Additional maintenance is carried out for the sensory garden at Kepple Lane Park. The Finance Committee of the Council meets quarterly and enables the six Councillors to study the finances of the Council in detail and make recommendations to Full Council.

The accounts are prepared in accordance with the Governance and Accountability for Smaller Authorities in England, March 2020. Members of the public are always welcome to inspect the books.



A big thank you to our Lengthsman who has continued to make the town look tip top throughout lockdown when we have seen an increase in littering and dog fouling. This year the Town Council purchased a new mower for the town to keep our open spaces maintained.




During June last year I instigated an extra ordinary meeting after receiving an open letter from a member of the community, to pursue the opportunities and rescue plan to ensure Garstang was a safe retail destination. We engaged with the community and invited members of the community and local organisations to discuss the impact of Covid on our town and how to adapt to the new challenges. The Market Town Working Group was born. Deputy Mayor, Cllr Allan volunteered to chair the group who met regularly. We worked with the Town Trust and assisted with the road closure for the weekly outdoor market. The Market Town Working Group also produced a new Heritage Trail leaflet which has been distributed throughout Garstang. The Market Town Working Group also set up a new Facebook page and website, This is Garstang to help promote all aspects of Garstang. Finally, The Greater Garstang Partnership Board evolved from the Market Town Working Group which has been set up to drive the development of a Regeneration and Investment Framework for the town and its surrounding villages. The Board involve a range of organisations and representatives who lead areas such as Health and Wellbeing, Business and Economy, Education and Skills.

The Town Council liaised with Save Garstang Pool Community Group and our local district and county councillors to lobby YMCA and Wyre Council on the reopening of the pool following the first lockdown. No sooner did we have an opening date of early January we went into another lockdown. The good news is the pool is due to reopen 1st May.

The Town Council this year agreed to sign up and join 'Our Lancashire'. Our Lancashire is funded by the Police and Crime Commissioner and the website is dedicated to not for-profit organisations - providing space to advertise the amazing work they do, promote their upcoming events, get their message out to new members or potential volunteers and network with other organisations. The Town Council also resolved to follow up the offer of free DBS checks for a number of councillors.

Garstang Volunteer Force has been a lifeline for the vulnerable and the elderly during lockdown. Having been involved with Garstang Volunteer Force since its inception, I encouraged them to apply for a grant application to Wyre Council. I'm pleased to report this application was successful and they were granted £500.



Paula Boscott's under the glitterball event was cancelled but most still very kindly donated their ticket money!

Sales of John Waite's book a Ramble around Catterall & district have continued; We have lost very dear family & friends during the pandemic & donations have been made in their memories;

Friends have had significant events in their lives but as they couldn't celebrate as they would normally do they have made donations in lieu of events & gifts; Friends have held personal events such as the mini tractor run & lone sponsored bike ride;

Churchtown in bloom held outdoor honesty box sales, as Team Matt did with puzzles & books (to keep folks entertained whilst not able to go out) on Cockrobin lane.

Sales of masks made & sold by our friends at Quilters Quarters, Longridge, sold at Best Wishes garstang & our neighbour Pat, made & sold them at Nicksons; Trisha Barker painted pebbles & friends @ Longridge Highland Cow offered them outside for donations; Handmade cards sold; Mike Coleran sold a canvas; Sale of Wyre lottery tickets; Clothing collections, especially from our green recycling box on Catterall village hall.

To date the fund has screened just shy of 1,500 young people 38 have been referred for very serious/ potentially fatal conditions A further 37 have had letters of advice sent to their GPs regarding less serious anomalies that nevertheless need checking/addressing.

A weekend long screening costs £10,000, testing up to 200 young people so that equates to £50 per test - not a lot to potentially save a life! Screenings directly benefit our young people here in Garstang as the screening testing site is generally at Garstang Community Academy.

I think you will all have guessed, I am very proud to announce the winner for this year's Town Council Mayor's award is Paula Hesmondalgh. On behalf of Garstang Town Council, thank you for everything you do for our young people.

Finally I am proud to announce my lockdown fundraising total for this mayoral year. £1150! I will be donating £575 to both Garstang Millennium Green and Garstang Christmas Lights.

# **Garstang Youth Council**

We began virtual youth council meetings mainly to stay connected throughout the unforeseen times that we were living through. I have always been a very optimistic person, but when it comes to Covid-19, I believe we could still be living under restrictions for many years to come. So, with this in mind, I decided to change the format of the Garstang Youth Council meetings turning them into more of a debating society which is how they remain.

**Christmas Lights Group Report** 

The Christmas lights group is a small group with representation from Garstang Town Council, Garstang Town Trust, Garstang Chamber of Trade and the general public, with the purpose of facilitating the Christmas festive lights in Garstang. In 2020 we were in year 3 of a 5 year contract with our suppliers, LITE, for the Christmas festive lighting scheme in Garstang. The Christmas lights are illuminated from the end of November to the beginning of January, to bring social and economic benefits to the town during the darkest months of the year. The LED lights we use are efficient, using modern low energy technology.

The lighting scheme design we introduced has been credited for bringing a 'positive feel' to Garstang particularly after the year we had experienced with the pandemic, brightening our town over the festive period. We have received anecdotal positive feedback from locals and visitors alike. The lights cost approximately £12,000.00 + VAT. After generous donations from Wyre Council, Garstang Town Council and Garstang Town Trust (and VAT reclaim) we are left with approximately £6,000.00 to raise. 2020 Was a challenging year for fundraising, we used different avenues than previously and were overwhelmed with the generous help we received. We contacted other local parish councils and most contributed funds for the lights, we also set up a 'Go fund me' page and were active on Facebook which contributed to raising awareness and funds. Business collections were down (as expected) however we still received donations from many. Also, we had other individual groups collecting for us alongside businesses; from raffles to dressing in costume collecting. With this and the extra donation from Garstang Town Councill and the Town Trust, also the 'Mayoral allowance' the Mayor kindly donated alongside £1200 reduction in the invoice we negotiated, we were able to reach our target to pay for the lights for 2020.

Our intention is to save any surplus to extend the lights scheme further around the town, on Park Hill Road and Bridge Street and currently we are negotiating with LITE about costs. The Light Switch on was held virtually and broadcast live over Facebook. Once again this went down well with many positive comments.

There is no doubt that the Christmas Lights are an important part of Garstang's calendar and the help that Garstang Town Council gives financially and practically is invaluable.

Garstang Town Trust is made up of eleven Trustees' all of whom live within a two and a half mile radius of Garstang town centre. Once we are able to resume normal meetings there will be several changes to some of the Trustees. Just before lockdown one of our longest standing Trustees Mr Eddie Livesey retired from the Trust after a service of 46 years. Mr. Livesey will be well known to many in the town as he has been involved with many local organisations. Unfortunately the Trustees were unable to make a presentation to Mr. Livesey due to the then newly implemented Covid regulations. Therefore Mr. Livesey's daughter, Mrs. Julie Bell, was asked to make the presentation on behalf of the Trust. Mr. Bill Chippendale had continued to assist on market day since his retirement from the position of Clerk and Market Superintendent more than a decade ago but has now fully retired, although if it were not for the Coronavirus I am sure he would still have been going strong.

The remit of the Town Trust is to run the markets in Garstang, both the indoor Market House and the Thursday street market. All the money raised from the running of the markets and the rental from the businesses with in several prominent listed buildings that are under the guardianship of the Trust, these being the old Town Hall, the Market House, the Old Grammar School and slaughter house which is one of the oldest buildings in the town and has now been renamed 'Butchers Court', stays with in the town and is used for the upkeep of the buildings. If there is surplus income it can be given, at the discretion of the trustees, as grants to local community groups. The Trust is also responsible for the Market Cross which was first listed as an historical monument on 27th February, 1957.

The Town Hall and the Market House between them provide premises for seven businesses. Unfortunately over the last year the businesses in the Town Hall have, like so many others, been closed for a large part of the year due to the coronavirus. The businesses in the Market House have, being food outlets, tried to remain open were possible. Were it has not been possible they have provided a delivery service to many customers who were unable to get out to the shops. The old Grammar School which is better known as Garstang Arts Centre has also unfortunately had to be closed for most of the past year, as has the outdoor market.

The planned maintenance and repair work to the buildings last year included, replacement of skylights in the flat roof at the Arts Centre, replacement of windows to the rear of the Town Hall, replacement of the wooden panels under the arch in the Town Hall and painting of the internal communal areas. All these jobs were completed. This year we have made repairs to the back wall of the Town Hall, both inside and out, repairs to the woodwork on the gable end, replacement of broken or missing vent covers and now the exterior walls are being painted. There is another window yet to be replaced at the front South corner of the Town Hall which is in progress.

# **Market Town Working Group**

The Market Town Working Group (MTWG) was set up in June 2020 after the Town Council had received communications from The Chairman of Independent Garstang Traders (IGT) and the owner of Market Place News. Both had raised concerns about the High Street's recovery from the Pandemic lock downs and wanted the Town Council to coordinate efforts to support businesses through the lockdown periods and support the re-opening of our High Street.

In response to these requests the Town Council held an Extraordinary Council Meeting on 8<sup>th</sup> June 2021 and invited local businesses and organisations. The meeting agreed that we should set up a Market Town Working Group drawing its membership from local business, Town Council, Wyre Council, neighbouring parishes, Town Trust and other local organisations and members of the local community. At the time of this meeting in June 2020 the Chair of IGT had resigned.

This initial meeting on 16<sup>th</sup> June 2020 was well attended with 25 representatives from businesses, community groups, Town Trust, Town Council and neighbouring Parish Councils and Wyre Council.

It was agreed that we should set up two subgroups to address short term needs, the Implementation Team and the longer term recovery plan, The Strategy Planning and Funding Team. These teams are headed by Cllrs Dyer and Pearson. It was made clear that both short term and long term activities needed significant input from businesses and the community if they were to make a difference. Meetings were organised on a weekly basis until 18th August.

The MTWG considered that a Thursday Market Day road closure would be a necessity if the Market was to be re-opened. The road closure was discussed at length in June with business and residents having an opportunity to consider the pros and cons. Wyre and LCC highways officers and the police were consulted. It was determined that we should implement the road closure from 9am to 4pm on Thursdays. The closure was in place from mid July until Christmas. Volunteers manned the entrance to the High Street to ensure that High Street residents had access to their properties. We also allowed access for delivery vehicles and some essential shops on Bridge Street. The road closure was generally received well.

Strategic Planning and Funding Team: The SPF Team has been working with Wyre Council Economic Development Team to determine the overall approach to create a document that can be used to attract strategic funding to enable Garstang and the surrounding areas to thrive into the future. This document would provide a vision of the needs of the local area covering a 15 year period. The team recognised that it did not have the skills and experience required to ensure the greatest opportunity to raise significant levels of funding to address priority requirements.

The SPF team were tasked with establishing the Greater Garstang Partnership Board drawing on expertise from around the borough. We have been successful in setting the Partnership Board up with membership providing a broad range of skills. We have secured board members from Myerscough College, Lancaster University, Blackpool Transport, Lancashire Enterprise Partnership, local businesses and many other disciplines.

The Partnership Board had its first meeting on 14th April and it will be concentrating on the development of a 15 year vision for Garstang and the surrounding districts. This will need significant consultation with people in the local community, residents and businesses over the next 12 months. The Board will be instrumental in the development of a regeneration framework which will identify the major projects that will need to be delivered to realise the vision.

Implementation Team: The MTWG wanted to see a consolidation of the many social media sites supporting different aspects of Garstang; Business - General Info - Traffic. The group suggested that we should have one site promoting the town and surrounding areas and This is Garstang was created to address this.

Wyre Council advised us that they had access to a national scheme and funding under Re-opening High Streets Safely Fund (RHSSF). Wyre had access to £98,000 across the four Wyre service centres which included Garstang as the only service centre in the east of the borough.

Working with Wyre we established that 50% of the fund would be held and used from a central pot and that each of the 4 service centres would be able to draw on £12,500 to address short term RHSSF needs. This fund is retained by Wyre and we can call off on agreed spend.

Wyre suggested a number of RHSSF ideas including Sound Systems and Hand Sanitiser Stations. The view of the MTWG was that our shops and businesses had already catered for hand sanitisers and that additional stations were not essential. It was also considered that a sound system broadcasting the Hands Face Space message was not practical for Garstang whereas it might be appropriate for the larger centres. Wyre subsequently supplied 2 Hand Sanitizer Stations from their central pot.

Bollard covers were suggested but blocked by LCC.

We had agreed to the purchase of pavement stickers but unfortunately Wyre deemed them a trip hazard.

We are in the final stage of discussions on a number of tools we plan to deploy around the town centre which will enable us to highlight different business initiatives around the district which can be provided in a covid safe environment.
