Attendees

The latest government guidelines, Coronavirus: how to stay safe and help prevent the spread, were updated on 19th January 2022. From 27 January, there is no longer a legal requirement to wear a face covering. The government suggests that you continue to wear a face covering in crowded and enclosed spaces where you may come into contact with other people you do not normally meet.

Until the 27/01/2022 the COVID Meeting Risk Assessment details the following:

The wearing of masks is required in any circulation spaces and where it is not possible to maintain social distancing of a minimum of 1 metre. Attendees will be required to wear a mask for the duration of the meeting unless for medical reasons you are exempt and may be removed to speak.

You should carry out a lateral flow test before the meeting and within 24 hours of your attendance. Do not attend if the test is positive.

Do not attend the meeting if you have any symptoms of Covid-19.

Sanitise your hands prior to the meeting using the hygiene station at the entrance to the meeting room.

In addition if you are experiencing any COVID symptoms again you should not attend the meeting and book the appropriate PCR test. Councillors who cannot attend the meeting should give their apologies and a reason to the Clerk.

As per the risk assessment, the windows will be open to increase ventilation. The meeting room may be cold so please wrap up warm!

Recording of Public Council Meetings

Please be aware that the public meeting may be recorded for the accuracy of the minutes.

As per standing orders 12g; for any meeting that has been recorded the recording will be kept for a period of 6 months after the minutes have been approved as accurate before the recording is deleted.
